

# **Round Denmark Bike Race release and waiver of liability:**

For consideration of participation in the Round Denmark Bike Race event to be held beginning on Sunday the 6th of July, 2026 and ending on Sunday the 26th of July, 2026,

I, \_\_\_\_\_, waive and release the Round Denmark Bike Race ("RDBR"), its directors, officers, administrators, representatives and executors, past and present volunteers, agents, supervisors, participants, all city and state governments, assigns, all sponsors, their representatives and successors and other persons (collectively, the "Releasees"), from any and all claims, liabilities, or causes of action arising out of an injury to me (or my child) and from any and all claims, liabilities, or cause of actions arising from my (or my child's) participation or attendance in this event.

## **Inherent and Potential Risks**

I understand that the Round Denmark Bike Race involves strenuous physical activity associated with bicycling very long distances over the course of several days. I understand that physical activity, by its very nature, carries with it certain inherent risks. I assume all risks associated with participating in the Round Denmark Bike Race relating to the risk of strenuous physical activity, collisions with other riders, or falling off of my bicycle. I acknowledge that I (or my child) may incur minor injuries, major injuries, and catastrophic injuries including paralysis and death. I assume all risks from contact with other participants and volunteers, negligent or wanton acts of other participants and volunteers, any defects of conditions of road surfaces (including uneven, wet road surfaces or gravel surfaces), failure of cyclists, vehicles, and non-participants to observe traffic signals or laws, and the effects of weather including high heat, thunderstorms, lightning, precipitation, cold temperatures, high winds, and/or humidity.

I acknowledge that my participation in the Round Denmark Bike Race involve overnight stays and time off of my bicycle where I am still attending the Round Denmark Bike Race event. I assume all risk for any and all activities in addition to cycling that I (or my child) engage in throughout the entirety of the Round Denmark Bike Race event, including my (or my child's) safety from the beginning of the Round Denmark Bike Race to the conclusion of the event.

I agree to dress myself (or my child) appropriately as to mitigate risk of physical injury to myself (or my child) including, but not limited to: wearing shoes appropriate for strenuous cycling involved in the Round Denmark Bike Race; and dressing in conjunction with the weather. I understand that wearing a helmet, that satisfies CE standards or similar, is a requirement to participate in the Round Denmark Bike Race. I agree to wear a helmet that satisfies safety standards for the entirety of my participation in the Round Denmark Bike Race.

I agree to wear a reflex vest, from dusk till dawn, while riding in the Round Denmark Bike Race.

I agree to uphold the Danish National Traffic Act and use appropriate bicycle light, with a minimum viewable distance of 2 km, from dusk till dawn. The light should be viewable from both sides simultaneously. And I agree to uphold the Danish National Traffic Act and use an appropriate bicycle bell.

I agree that the Releasees are not responsible for any personal items or property lost or stolen before, during, or after Round Denmark Bike Race.

## **Medical Evaluation**

I attest that I (or my child) am medically and physically able to participate in the Round Denmark Bike Race. If I experience any doubt as to my (or my child's) ability to successfully and safely participate in and/or complete the Round Denmark Bike Race, I take full responsibility for consulting a physician. I attest that, if I (or my child) am pregnant, disabled in any way, or have recently suffered an illness, injury, or impairment, I (or my child) should have or did consult a physician prior to participating in the Round Denmark Bike Race.

I consent to emergency medical care and transportation in the event of injury to me (or my child) as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligent emergency rescue operations.

I attest that I am covered by sufficient medical- and liability insurances during the entire event. Including coverage for home transportation in the event of serious injury or death.

## **Voluntary Participation**

I am fully aware of the risks connected with participation in the Round Denmark Bike Race, whether specifically listed in this Release or not, and I voluntarily elect to participate in the Round Denmark Bike Race knowing that this participation involves these risks.

## **Assumption of Risk, Waiver of Liability, Release, and Covenant Not To Sue**

In consideration for being permitted to participate in the Round Denmark Bike Race, I voluntarily agree for myself, my family, heirs, assigns, executors, and administrators to the following:

1. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me (or my child), or any loss or damage to property owned by me (or my child), as a result of participating in Round Denmark Bike Race.
2. TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, AND COVENANT NOT TO SUE the Releasees from any and all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me (or my child), or to any property belonging to me (or my child), while participating in the Round Denmark Bike Race including, but not limited to, any claim that the act or omission complained of was in whole or in part by the negligence or carelessness of the Releasees.

## **Acknowledgment and Compliance with Rules**

I agree to observe all rules and safety procedures that accompany the Round Denmark Bike Race and to abide by any decision of an event official relative to my (or my child's) ability to safely participate in the event. I agree to exhibit appropriate behavior at all times and to obey all laws. The RDBR and event officials may dismiss me (or my child), should my (or my child's) behavior endanger the safety of or negatively affect an event, person, facility, or property of any kind.

## **Severability**

I agree that if any portion of this Release is deemed to be invalid, the remainder of the Release will still be binding and enforceable.

## **Photography Release**

I hereby grant full permission to the RDBR to use, reuse, reproduce, publish, or republish any photographs, motion pictures, recordings, or any other record of my participation in this event, in any medium now known or hereafter developed, alone or in conjunction with other material, without restriction as to changes or alterations, as well as to use my name, voice, likeness, and/or other indicia of identity, for editorial, educational, promotional, advertising, and commercial purposes, including without limitation in

connection with the solicitation of contributions and the furtherance of the objectives of the RDBR. Further, I relinquish all rights, title, and interest in any and all photographs, motion pictures, recordings, or other records of the Round Denmark Bike Race I may take or capture to the RDBR.

I acknowledge and represent that I have carefully read and understand all terms of this Release and Waiver of Liability.
